Pilot Entry Form | Acknowledgment of Responsibility

While participating in the Balloons & Tunes Festival in Artesia, New Mexico, I hereby certify that I am aware of and agree with the responsibility legally transferred to me under the Federal Aviation Regulations as regard to my personal decision to fly my balloon(s), and any bodily injury or property damage resulting there from is solely my liability. I further agree that none of the flights are mandatory, that all flights are voluntary and at my sole discretion.

I hereby agree to have in full force during the Artesia Balloons & Tunes Festival a balloon insurance policy in the amount of either (1) \$100,000 / \$300,000 minimum bodily injury, \$50,000 minimum property damage: or (2) \$100,000 minimum single limit. I further agree to have in full force during the Artesia Balloons & Tunes Festival/Balloon Rally a balloon insurance policy in the amount of \$100,000 minimum passenger liability for each and every passenger I carry.

I agree that the organizers and sponsors of the Artesia Balloons & Tunes Festival/Balloon Rally are providing me with the facilities and means for my participation in this rally and in no way do they supersede the responsibility of the pilot in command as stated in the Federal Aviation Regulations.

It is my understanding that the pilot of each balloon is in full and complete charge and control of said balloon and is responsible for all decisions made concerning all things or persons in or connected with said balloon, whether on the ground or in the air. Officials of said rally may supply information, guidance or data, but I understand that I act or rely on such information at my peril, and said officials assume no responsibility for the completeness or accuracy of such information.

It is my understanding that the organizers may inspect all balloons entered in the event; but that such inspection is only for the purpose of determining whether the aircraft complies with all rules of eligibility of said rally. **The approval of the balloon by said officials does not constitute a representation or warranty of any kind or character whatsoever concerning the mechanical condition of the aircraft, or whether or not the aircraft is airworthy.**

I understand and agree to the terms and conditions outlined above and certify that all information furnished to the Artesia Balloons & Tunes Festival organizers is current, true and correct.
